The town has paid off the remainder of the library bond totaling \$147,390.35. The bond payment includes payment of next year's installment in order to save on debit services. The Capital Campaign Committee contributed \$20,000 to the town for the payment on the loan in 2016.

Bruce, and Ron Knight met with John Moffit. John asked for \$20,000 at this meeting. The Capital Campaign Committee honored his request. This brings total payments to the Town of Mendon from the Capital Campaign to \$444,908. The Capital Campaign will continue to fundraise until August 2016.
